Terms and Conditions

In consideration of the DuPage County Historical Museum ("Museum") agreeing to authorized use of reproductions from the Museum's collection listed above, the Borrowing Institution ("Borrower") agrees to the following as terms and conditions of this loan:

1. To use the reproduction only once and only for the purpose listed. A subsequent or different use (including subsequent editions, book club editions, paperback editions, different languages, etc.) constitutes a reuse and must be applied for in writing. There is a reuse fee.
2. To credit properly. The following is the credit line: DuPage County Historical Museum.
 - a. With printed matter, it is preferred that the credit line appear on the same or facing page as the illustration. Crediting of each individual item is mandatory.
 - b. With films and filmstrips, include the credit with the other "Sources of Illustrations." In manuals that accompany filmstrips, credit at the point where the illustrations is discussed.
 - c. With exhibitions, credit within exhibition area.
 - d. With public displays, credit within display area.
3. To give the Museum one complimentary copy of any published work except motion pictures, in which the photographic copy appears.
4. To indicate in the accompanying caption or label any and all changes that you have made to the original photographic copy, such as taking a detail, superimposing, tinting, etc.
5. To return copy negatives and slides within 30 days of use unless otherwise specified. A holding fee of \$5 per week will be charged for each negative or slide held beyond its rental period. Although photographic prints do not have to be returned, they will be accepted by the Museum. No refunds will be made for unused or returned photographic copies.
6. Not to permit others to reproduce the reproduced materials or any facsimile of it.
7. In authorizing the use of these reproduced materials, the Museum does not surrender or in any way restrict its own right to reproduce or use the materials or to grant permission to others to do so.

8. It shall be the responsibility of the Borrower to secure any other rights necessary for the reproduction of the materials. The Borrower agrees to defend and hold harmless the Museum, the County of DuPage, Illinois, and their employees and agents against any and all claims in connection with Borrower's failure to secure such rights.
9. Despite acceptance of agreement, the Museum may at anytime revoke authorization to use reproduced materials based on determination that use would in any way injure material or infringe on another's right or interest in them.
10. The invalidity of any portion of this agreement shall not affect any other portion not dependent upon it.
11. Any exceptions or additions to this agreement will be attached to and considered part of this authorization form.
